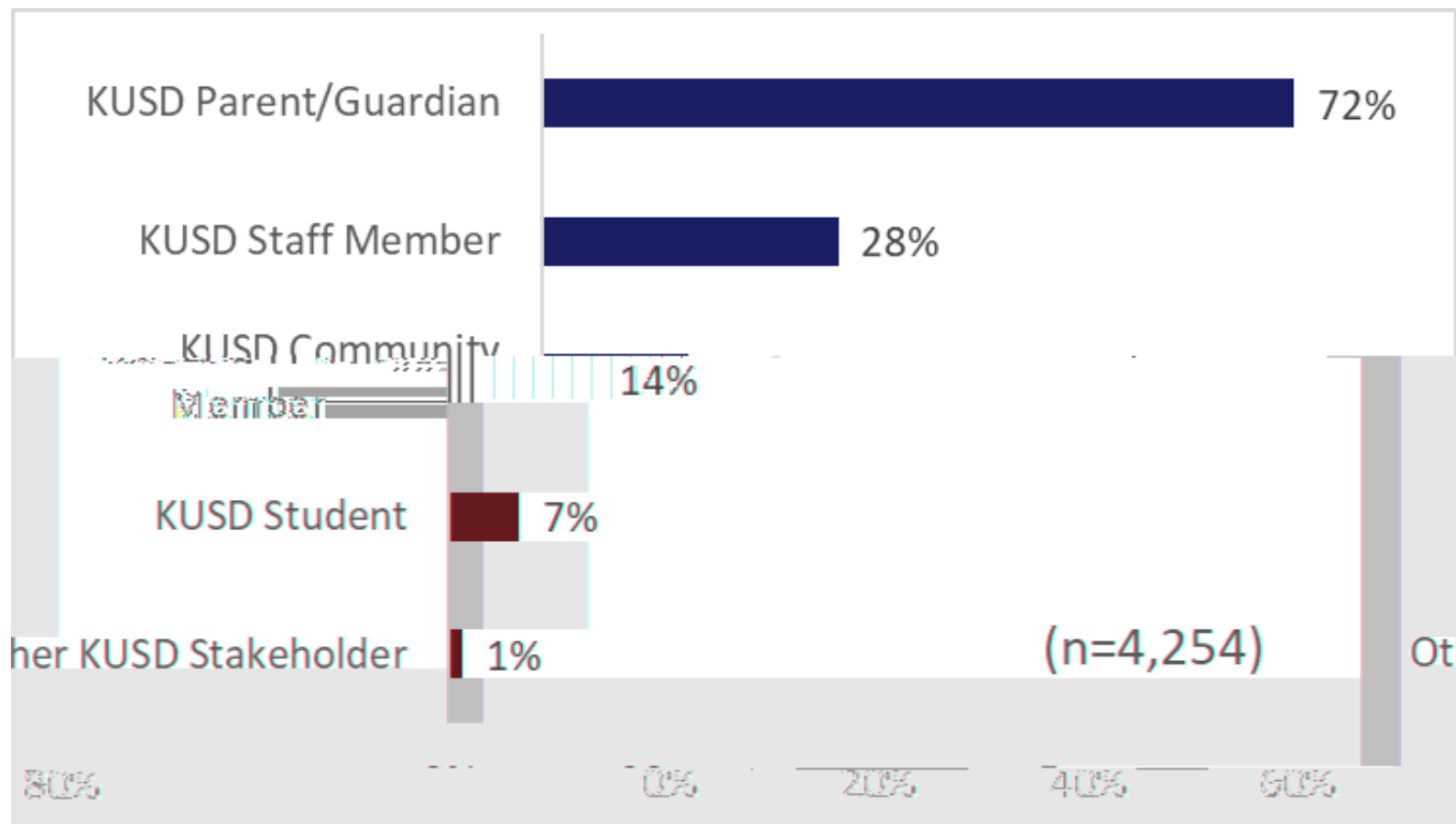
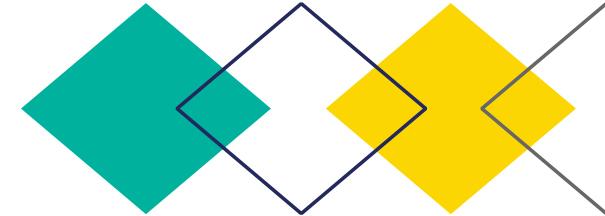

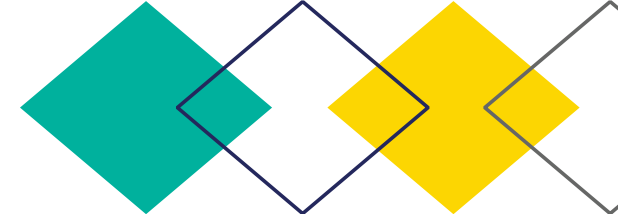

What describes your relationship with KUSD?



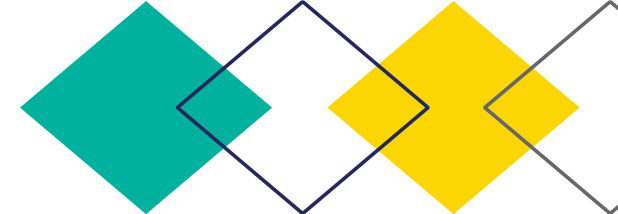

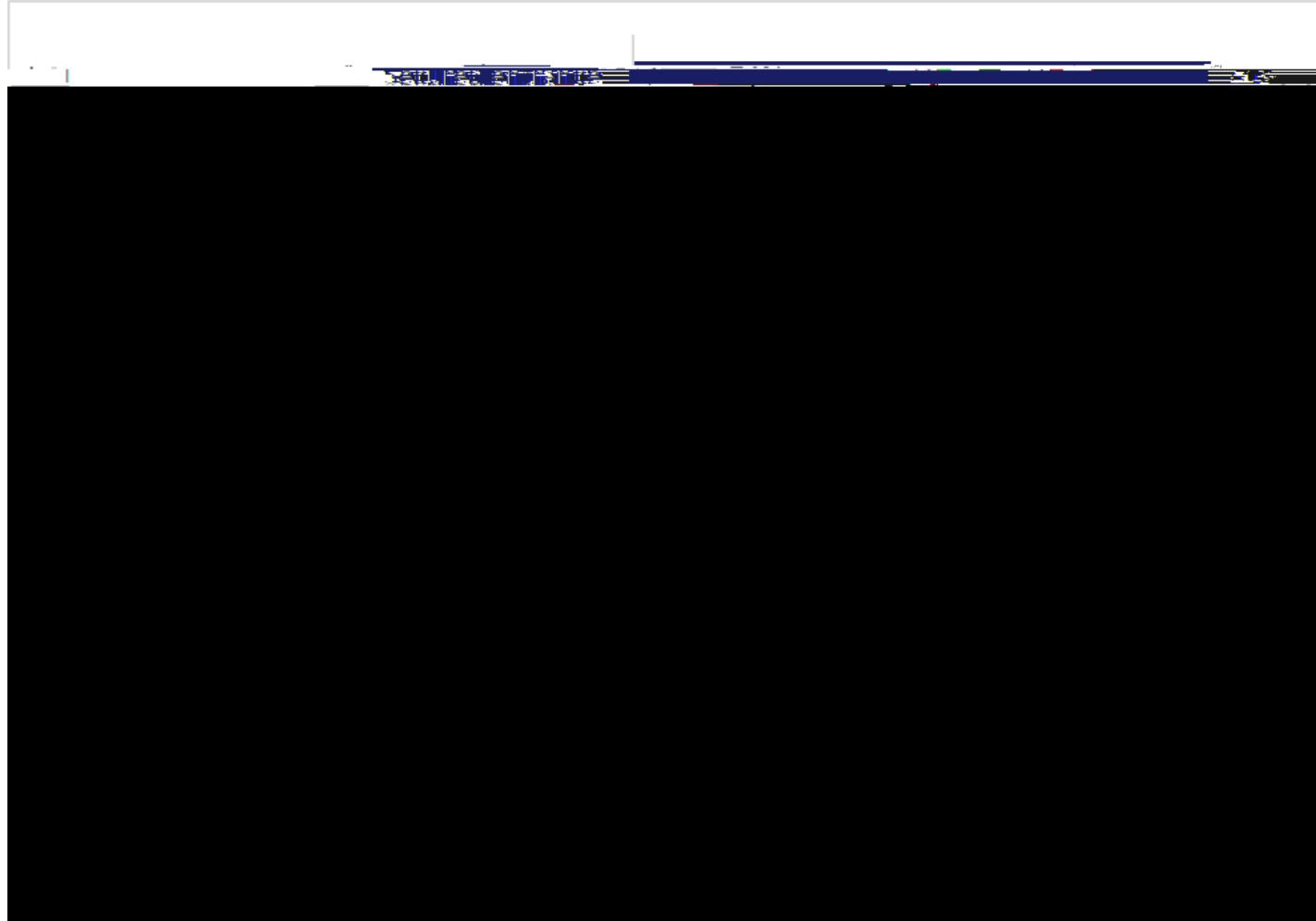
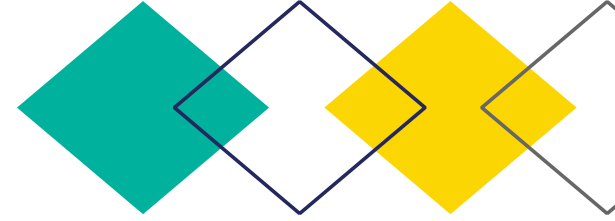
What rightsizing objectives are MOST important to you?



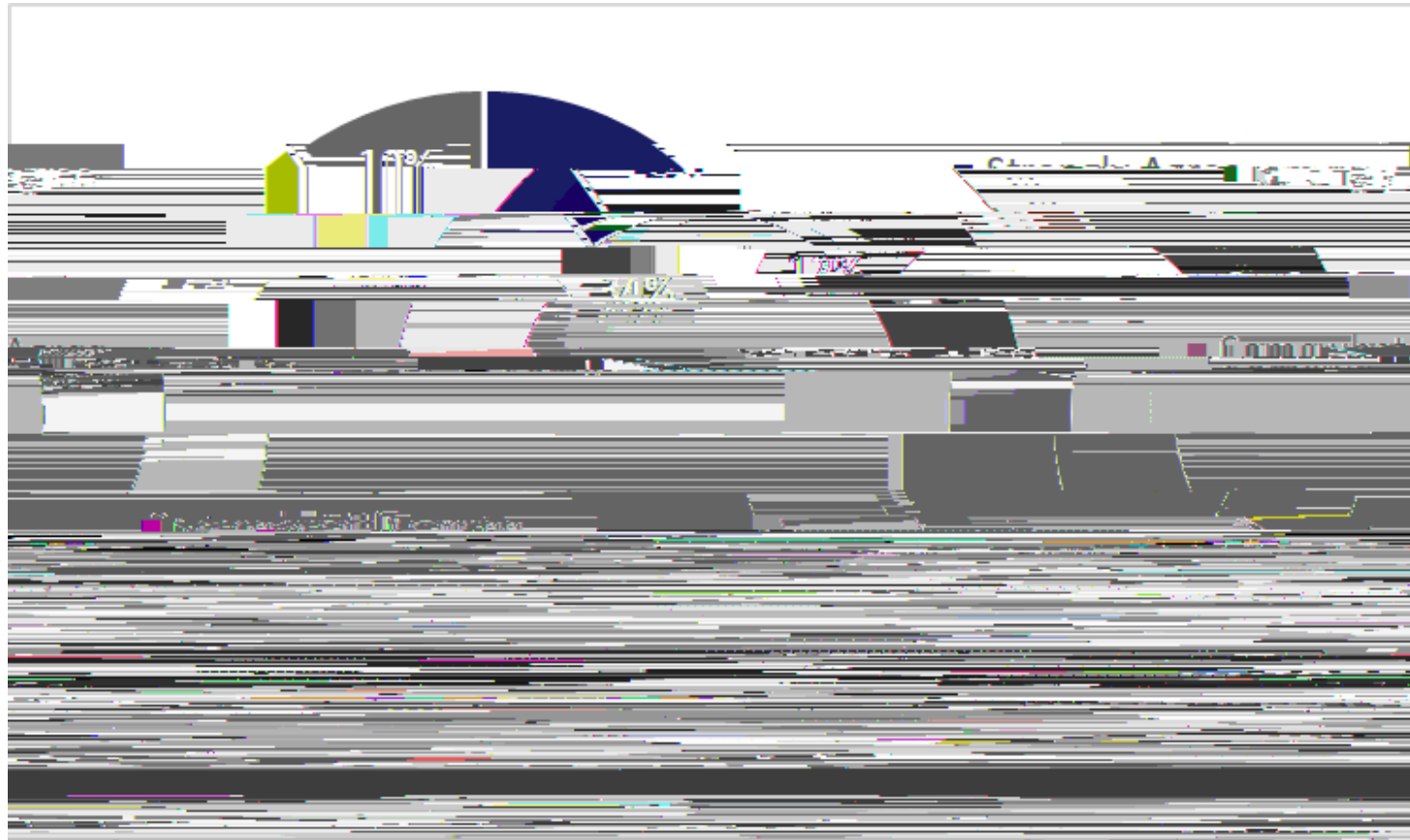
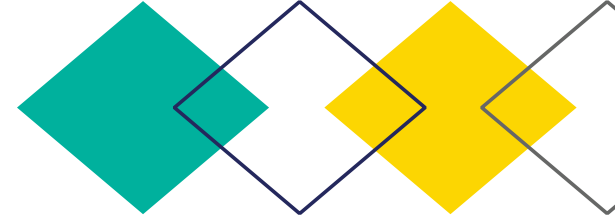
What rightsizing objectives are LEAST important to you? (Choose 2)



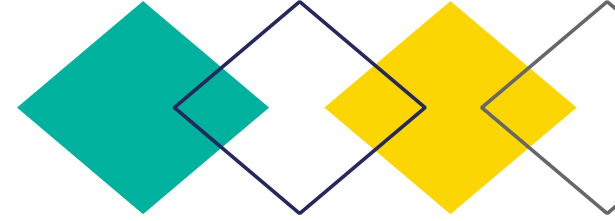
Of the following options, what should be included in the basic standard requirements of a school building/facility? (Choose 5)
